Volunteer Victim Advocate Training

The Women's Coalition of St. Croix's (WCSC) Volunteer Victim Advocate Training provides practical techniques for offering support to victims in crisis. Trainees also gain knowledge on many relevant issues, including domestic violence, sexual assault, child abuse, legal and medical aspects and community resources. Workshops with various professionals from local public service agencies are also conducted, including the V.I. Police Department, Legal Services of the Virgin Islands and the V.I. Department of Human Services.

WCSC holds volunteer victim advocate training approximately every 18 months. The last training was held in September 2013. Please contact us at (340)773-9272 for information on the next training sessions.

In order to be certified by WCSC, volunteers must:

-  **be 18 years of age or older**
-  **commit to complete the six-week victim advocate training**
-  **commit to a one-year internship as an advocate-in-training**

Advocates must drive their own vehicles for on-duty periods.
